

Regulations for the Implementation of a Quality-Oriented Method of Remunerating Academic Teachers under the "Excellence Initiative – Research University" (IDUB) Programme – "Publication Award"

§ 1 General Provisions

1. These Regulations define the principles for implementing a quality-oriented method of remunerating academic teachers under the "Excellence Initiative – Research University" (hereinafter: IDUB) programme, through the motivational supplement "Publication Award" (hereinafter: the Award) for individuals engaged in high-quality publication activities.
2. Whenever these Regulations refer to:
 - 1) **Minister's Announcement** – it should be understood solely as the Minister of Science's announcement of January 5, 2024, regarding the list of scientific journals and peer-reviewed conference materials for scientific publications and the Minister of Education and Science's announcement of July 22, 2021, regarding the list of publishers publishing peer-reviewed scientific monographs for monographs;
 - 2) **Scopus** – it should be understood as the online, multidisciplinary database by Elsevier, serving as a mandatory reference database providing bibliometric indicators for the IDUB programme;
 - 3) **TOP1** – it should be understood as journals classified in the top percentile of the most-cited journals globally according to the Scopus database list of June 4, 2024;
 - 4) **Co-authors from UWr** – it should be understood as co-authors of publications who, at the time of applying for the Award, meet the eligibility criteria, i.e., meet the conditions set forth in sections 4 and 5;
 - 5) **Publishing from January 1 do December 31, 2024** – it should be understood as a year of actual publication of the journal.
3. The Publication Award is intended to motivate academic teachers and doctoral students at the University of Wrocław to engage in high-level global publication activities.
4. Eligible for the Award are:
 - 1) An academic teacher employed by UWr on the date of submitting the application for the Award, provided that the publication is affiliated with UWr,
 - 2) A doctoral student – a participant of a doctoral school, provided that the publication is affiliated with UWr.
5. An academic teacher who has been subjected to a disciplinary penalty that has not yet been expunged is not eligible for the Award.
6. The Award is granted for:
 - 1) Scientific publications, published in their final version, from January 1 to December 31, 2024, that are affiliated with the University of Wrocław and are included in the University's employee scientific publication database on the date of the application, according to the point values for each discipline as specified in § 3, section 6 of these Regulations
 - 2) Scientific publications related to the "computer science" discipline, published from January 1 to December 31, 2024, that meet the following conditions:

- a. Have a value of 200 or 140 points according to the Minister's Announcement,
 - b. Are affiliated with the University of Wrocław and are included in the University's employee scientific publication database on the date of the application,
 - c. Are indexed in the DBLP database,
 - d. Were published as part of participation in an international conference categorized as A* in the CORE ranking during the year of publication.
- 3) Authorship of scientific monographs published from January 1 to December 31, 2024, that meet the following conditions:
 - a. Are related to the scientific disciplines of the University of Wrocław,
 - b. Have been published by prestigious publishers from level II of the list according to the Minister's Announcement,
 - c. Are affiliated with the University of Wrocław and are included in the University's employee scientific publication database on the date of the application.
- 7. The Award does not apply to the winners of the competition "Best of the Best – in Search of Teaching Excellence" under Task 11 of IDUB for publications forming the basis of the award.

§ 2

Conditions for Receiving the Publication Award

1. Applications for the competition must be submitted via the form to the address specified in the Rector's announcement. The form includes a statement by the applicant confirming that the information provided is accurate and consent for personal data processing.
2. The application form is outlined in **Annex 1** to these Regulations.
3. The competition schedule is announced in the Rector's announcement.
4. The condition for receiving the Award is obtaining a positive assessment of the application by the IDUB Office, based on the Evaluation Card, which is **Annex 2** to these Regulations.

§ 3

Principles for Awarding the Publication Award

1. A positive assessment of the application results in the IDUB Office submitting a list of eligible persons to the HR Department.
2. In the case of a negative assessment, the applicant will receive an evaluation card containing a detailed justification.
3. The Award for academic teachers is paid as a one-time motivational supplement in accordance with the remuneration regulations in force at UWr.
4. The Award for doctoral students is paid as a one-time supplement to their scholarship.
5. The Award for authorship of scientific monographs, as mentioned in §1 section 6, point 3, is 7,500 PLN gross. The list of disciplines is provided in **Annex 3** to these Regulations.

6. The Award for a publication is calculated as follows:

7. For publications in journals valued of 100, 140 and 200 Ministerial points and indexed in the TOP1 SCOPUS, as listed in **Annex 4** to these Regulations, the Award is increased by 1,000 PLN gross.
8. In the case of a single author/Co-author from UWr, they receive the full Award. In the case of multiple co-authors from UWr, the Award is divided equally among them.
9. Each UWr employee may submit a maximum of two publications in a single application, in which they are the author or co-author, qualifying for the Award. They may also receive a partial Award for other publications of which they are a co-author,

submitted under other UWr employees' applications according to the principles set out in section 8.

§ 4

Final Provisions

1. All personal data provided by the applicants are processed and stored for the purposes of the competition in accordance with applicable laws and are protected.
2. Information regarding the processing of personal data for individuals participating in the "Publication Award" motivational supplement competition under the "Excellence Initiative – Research University" program is provided in **Annex 5** to these Regulations.
