Information Clause

Pursuant to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (General Data Protection Regulation, GDPR), the University of Wrocław informs that:

1. The Controller of your personal data is the University of Wrocław, pl. Uniwersytecki 1, 50-137 Wrocław.

3. Your personal data will be processed under Article 6(1)(b) GDPR for the purpose of:
