Information Obligation Regarding the Processing of Personal Data

Acting pursuant to Article 13(1) and (2) and Article 14(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – GDPR), I hereby inform you that:

1. The controller of the data, responsible for ensuring that the processing of my personal data is carried out in accordance with the law, is the University of Wrocław, with its registered office at pl. Uniwersytecki 1, 50-137 Wrocław.
2. The data controller has appointed a Data Protection Officer, who can be contacted at the following e-mail address: IOD@uwr.edu.pl
3. Your personal data and the personal data of your underage child/underage person under your care will be processed pursuant to Article 6(1)(b) GDPR for the purpose of:
 - a. taking steps at the request of your child/the underage person under your care prior to entering into a contract, i.e. considering the application for allocation of a place/room in a student residence hall,
 - b. where a place/room in a student residence hall has been allocated and used – for the performance of the contract, the subject of which is the use of a place/room in a student residence hall.

The provision of personal data is voluntary, but it is a condition for the consideration of the application and, in the event of the allocation of a place/room in a student residence hall, it is a condition for the performance of the contract referred to in point 3(b) above.

4. Furthermore, your personal data and the personal data of your underage child/underage person under your care will be processed for the purpose of:
 - a) conducting proceedings for the granting of social benefits in the form of a place in a student residence hall pursuant to Article 104 of the Law on Higher Education and Science and pursuant to § 33(3) of Ordinance No. 196/2023 of the Rector of the University of Wrocław of 25 March 2023 on the introduction of the Regulations on Benefits for Students of the University of Wrocław (Article 6(1)(c) GDPR),
 - b) archiving and statistical purposes (Article 6(1)(c) GDPR),
 - c) in the case of applications submitted by persons holding a document confirming a degree of disability or other relevant documentation attached to the application (in addition Article 9(2)(b) and Article 9(2)(j) GDPR),
 - d) processing of data concerning gender (Article 9(2)(b) GDPR).
5. Your personal data will not be disclosed to external entities, except where required by law or by agreements entered into by the University of Wrocław.
6. You have the right to access your personal data and to have it rectified, as well as the right to erasure, restriction of processing, data portability, and the right to object to processing – in the cases and under the conditions set out in the GDPR.
7. Your personal data will not be transferred outside the European Economic Area (EEA).
8. Your personal data will not be subject to automated decision-making, including profiling.
9. Your personal data will be stored for the period of:
 - the limitation of claims that may arise in connection with your use of accommodation in a student residence hall – in the event that a place in a student residence hall is allocated,
 - the limitation of claims that may arise in connection with your application for a place in a student residence hall – in the event of refusal to allocate a place in a student residence hall.
10. You have the right to lodge a complaint with the President of the Personal Data Protection Office if you consider that the processing of your personal data infringes the provisions of the GDPR.
